

## Service Agreement Terms

1. "Bee eMail Services" (collectively the service) is provided by Bee Internet Ltd. with all rights reserved. The service consists of information services, software, and other content provided by the Service. In addition, third parties provide information, software, and other content (collectively, "Third Party Content") which may be accessed over the Service. These terms and any instructional screens published over the Service constitute the entire and only agreement (collectively, the "Agreement") between Bee internet Ltd. and members with respect to the Service and supersede all other communications and agreements with regard to the subject matter hereof.
2. Upon notice published over the Service, Bee eMail Services may modify this agreement or the associated rules, and may discontinue or revise any or all other aspects of the Service at its own discretion and without prior notice.
3. Member's right to use the service or to designate users is not transferable and is subject to the limits currently, or in the future, that may be established by the Service.
4. Member agrees to indemnify Bee Internet Ltd, any of its information providers, licensors, employees, and agents against liability for any and all use by member of member's account.
5. The Service is provided to the Member at no charge. However, to use the Service the Member must obtain access to the internet and an existing email account to which the Service shall forward to the Member's Email address. The member must pay any service fees associated with such access and or account. In addition, the Member shall provide all equipment necessary to connect to the World Wide Web, including a computer and a modem or other connection device. Member shall pay all applicable taxes related to the use of the Service by Member or its designated users. Member shall be responsible for all use of the Service accessed through Member's or its designated users password(s).
6. **The member agrees that the use of the service is at the member's sole risk. Neither Bee eMail Services, Bee Internet Ltd. or any of its information providers, licensors, employees or agents warrant that the service will be uninterrupted or error free. Nor does Bee Internet or any of its information providers, employees or agents make any warranty as to the results to be obtained from the use of the service. The service is offered on an "as is" basis without warranties of any kind, either express or implied, including but not limited to warranties of title other than those warranties which are incapable of exclusion, restriction or modification under the laws applicable to this agreement. Neither Bee eMail Services nor anyone else involved in creating, producing or delivering the service shall be liable for any direct, indirect, incidental, special or consequential damages arising out of use of the service or inability to use the service or out of any breach of any warranty. The member expressly acknowledges that the provision of this paragraph shall also apply to the third party content.**
7. **Member, upon becoming aware of any vulnerability (s) of the Service, that may exist now or in the future, agrees not to further exploit or disclose such vulnerability(s) except to Bee Internet LTD. 8. The provisions of paragraphs 6 and 7 are for the benefit of Bee eMail Services and its respective Information Providers, Licensors, Employees, and Agents; and each shall have the right to assert and enforce such provisions directly on its own behalf.**
8. This agreement is, and shall be governed by and construed in accordance with the laws of England and Wales.
9. Member agrees to be fully responsible and absolutely liable for any and all intentional or unintentional acts that are directly associated with member's username that result in a disruption to, improper use of, additional cost to, or an illegal act effecting the Service.
10. In consideration of the use of the Service, the Member represents that they are of legal age to form a binding contract and are not barred from receiving services under the laws of the United States or other applicable jurisdiction. Member, also, agrees to: (a) provide true, accurate, current and complete information about them as prompted by the Service's registration form (such information being the "Member Registration Data") and (b) maintain and promptly update the Member Registration Data to keep it true, accurate, current and complete. If the Member provides any information that is untrue, inaccurate, not current or incomplete, or Bee eMail Services has reasonable grounds to suspect that the information provided is untrue, inaccurate, not current or incomplete, Bee eMail Services has the right and may at its sole discretion suspend or terminate the Member's account and refuse any and all current or future use of the Service (or any portion thereof).
11. Unless otherwise specified, the Service is for your personal and non-commercial use.
12. If the forwarding address the member has provided is unreachable by the Service for an extended period of time or if the use of the Service by a member is determined to be adversely affecting other members of the Service the Service may at its sole discretion deactivate or terminate a member's account either permanently or temporarily.
13. The Service for the protection of its members has the right and may at its sole discretion terminate a member's Account either permanently or temporarily for violating any one or all of the terms put forth in this agreement.
14. Use of the Service signifies acceptance of this agreement.
